



**RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT  
North Olympic Football League – Future Riders**

In consideration of the City Parks & Recreation Department making available City and Port Angeles School District Facilities and/or coordinating certain recreational activities at said facilities, I, the undersigned, as the parent/guardian of the child named below, realizing no insurance coverage is provided by the City for the participants and understand that without this Agreement, the City would not be able to provide such recreational activities to the citizens of Port Angeles and Clallam County. I voluntarily, and of my own free will, elect to allow my child to participate as a member of the team in the league indicated below and will assume financial responsibility for any cost and/or damages pertaining to any accident or injury that might occur while participating in the named program.

I understand that there are certain risks and hazards involved in participating in football that may result in injury and/or death to my child or other players, including, but not limited to those hazards associated with equipment and other participants. I understand that the very nature of the game of football is hazardous and risky, including, but not limited to, the act of throwing, catching, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause injury or death to my child and other players. Further, I agree that in consideration for the right of my child to play as a member of the team designated below, and in consideration for permission to play on the fields arranged for by the team or league:

■ On behalf of my child, I voluntarily elect to assume all risks of injury incurred or suffered by my child while; (a) practicing or playing as a member of the team so designated; (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by the players on my child's team and; (c) while on or upon the premises of any and all courts arranged for by my child's team or league for practice or play.

■ In addition to giving my full consent for my child's participation, I release, discharge, agree not to sue or hold the City of Port Angeles, Olympic Football League or the Port Angeles School District owners, officers, agents, servants, associates, persons, entity or anyone connected with the team or league in the named program, responsible for any claim, damages, cost or cause of action which have or may in the future have as a result of injuries, accidents or damages sustained or incurred by my child.

I hereby certify that my child is fully capable of participating in the designated sport and that my child is healthy and has no physical or mental disabilities or infirmities that would restrict full participation in these activities, except as known to coaches and officials of the team and league.
